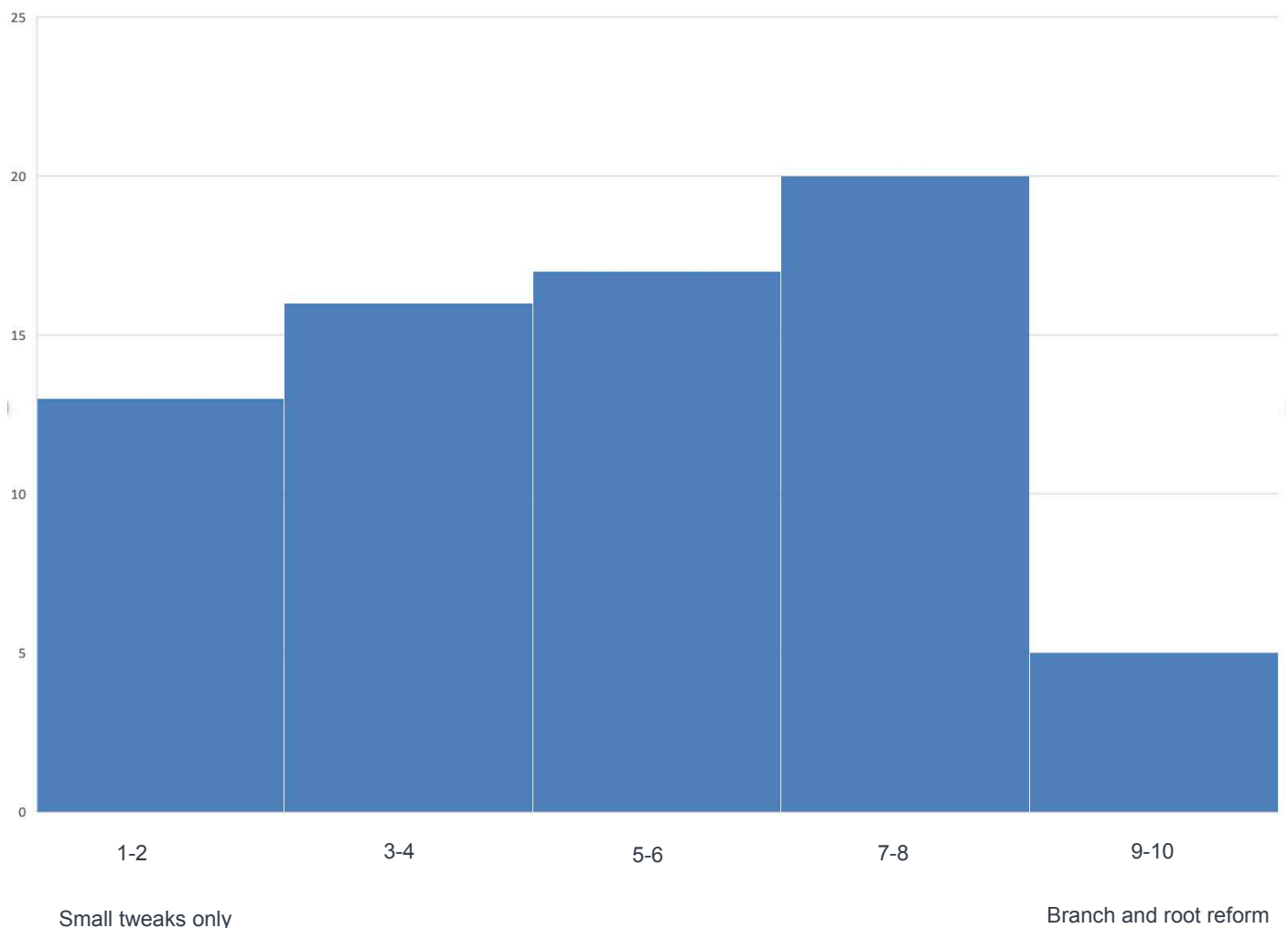


## New London Architecture (NLA) member survey results – ‘Planning for the future’ consultation

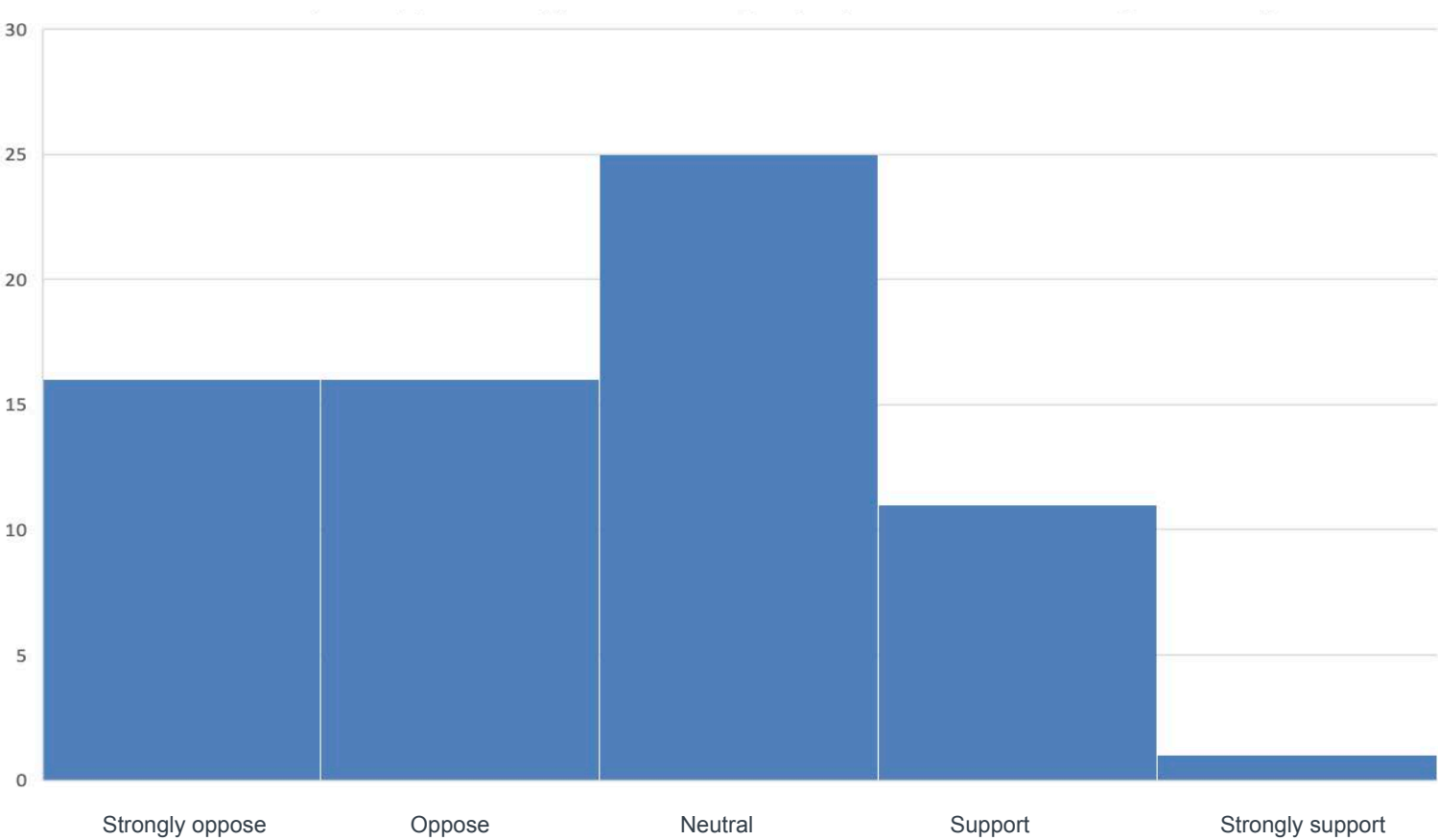
In September 2020, NLA conducted a survey of its membership to understand their views on the implications of the government’s proposed planning reforms for Greater London. The survey received detailed written responses from 69 organisations across the NLA membership, across architecture, development, planning, consultancy, local authorities, BIDS and charities. These were reviewed by the NLA Expert Panel on Planning and informed **NLA’s official consultation response**. Here you can see a summary of responses to our key questions.

Q5 How fundamentally do you believe the planning system needs to be reformed? Rating 1-10



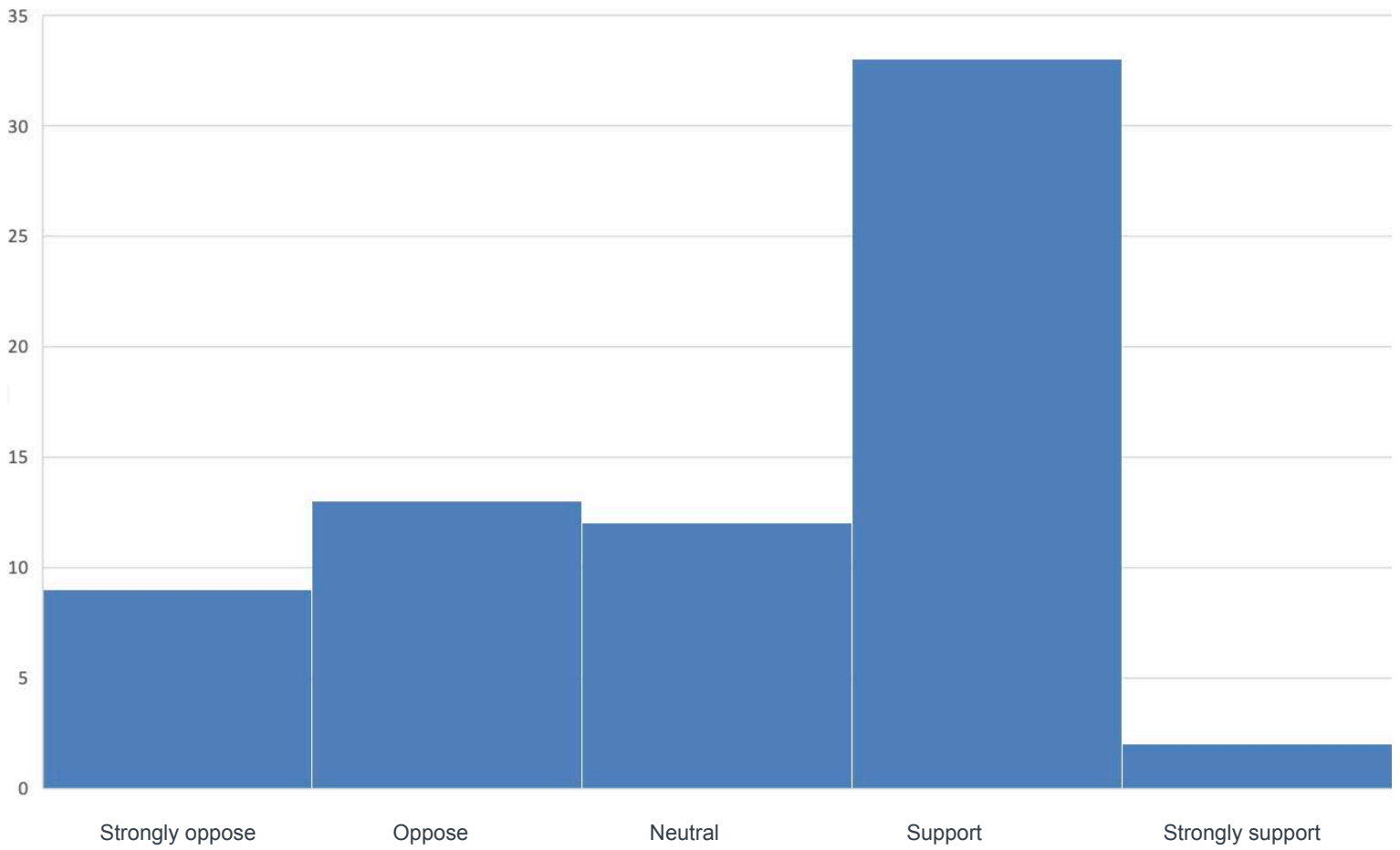
Q7 Overall do you support or oppose the changes proposed in the Planning White Paper?

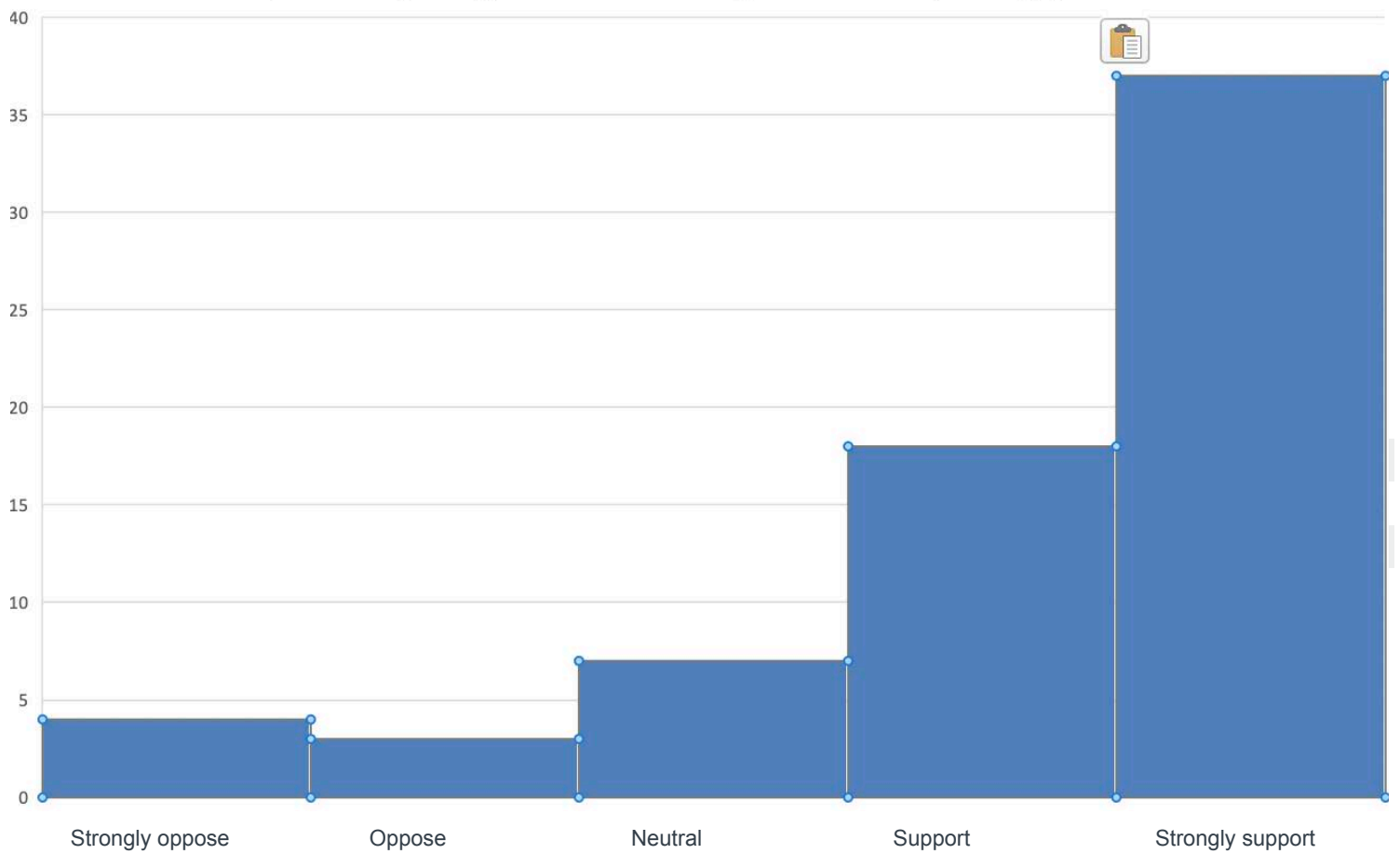
Q9 Would you support the proposed move to a shorter form, map-based Local Plan?

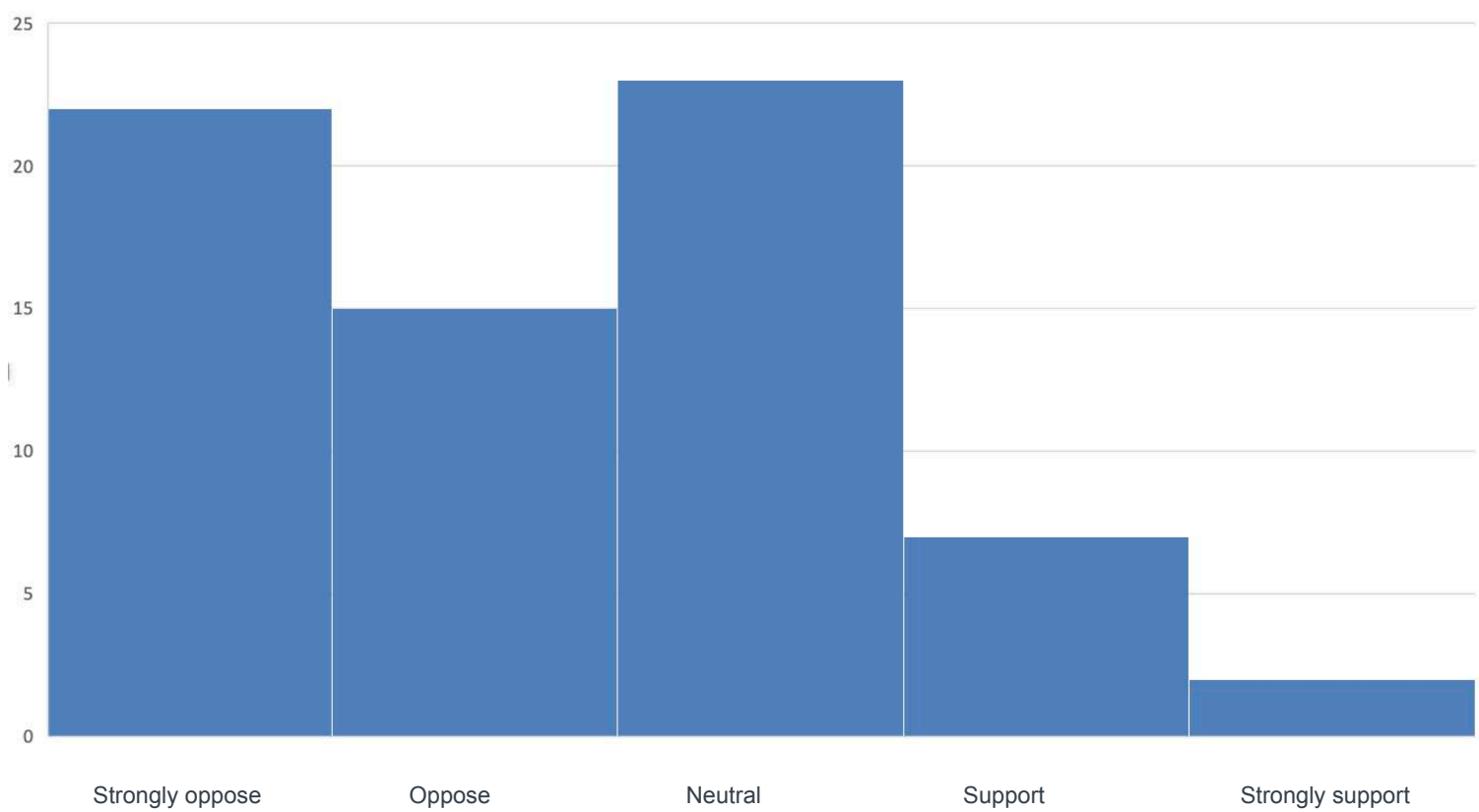
## Q11 Would you support the increased digitisation of the planning system?

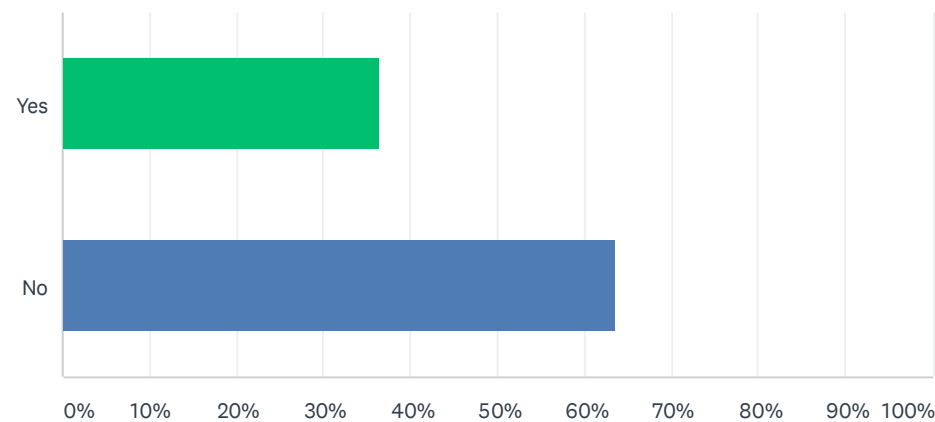
Q13 Do you support the proposed categorisation of all land as either ‘growth, renewal or protect’?

Q15 Do you believe that standardised design codes and pattern books will lead to better design quality?

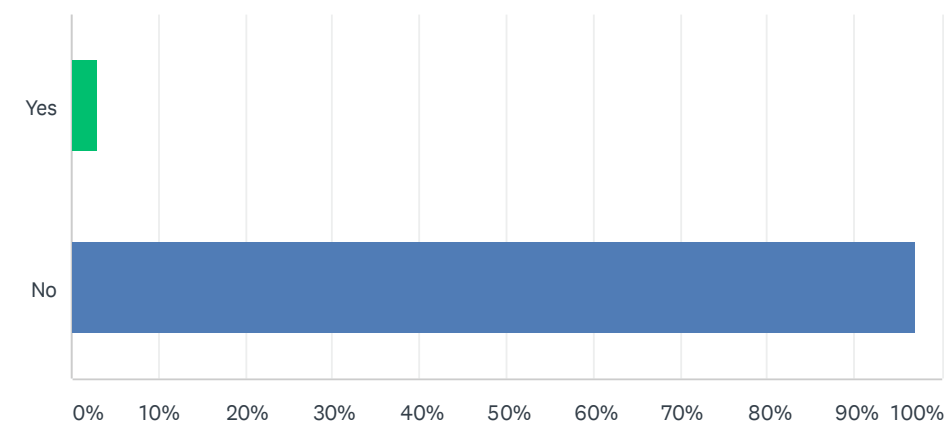

Q16 Do you believe Local Authorities will be adequately resourced to manage the new Local Plan process?

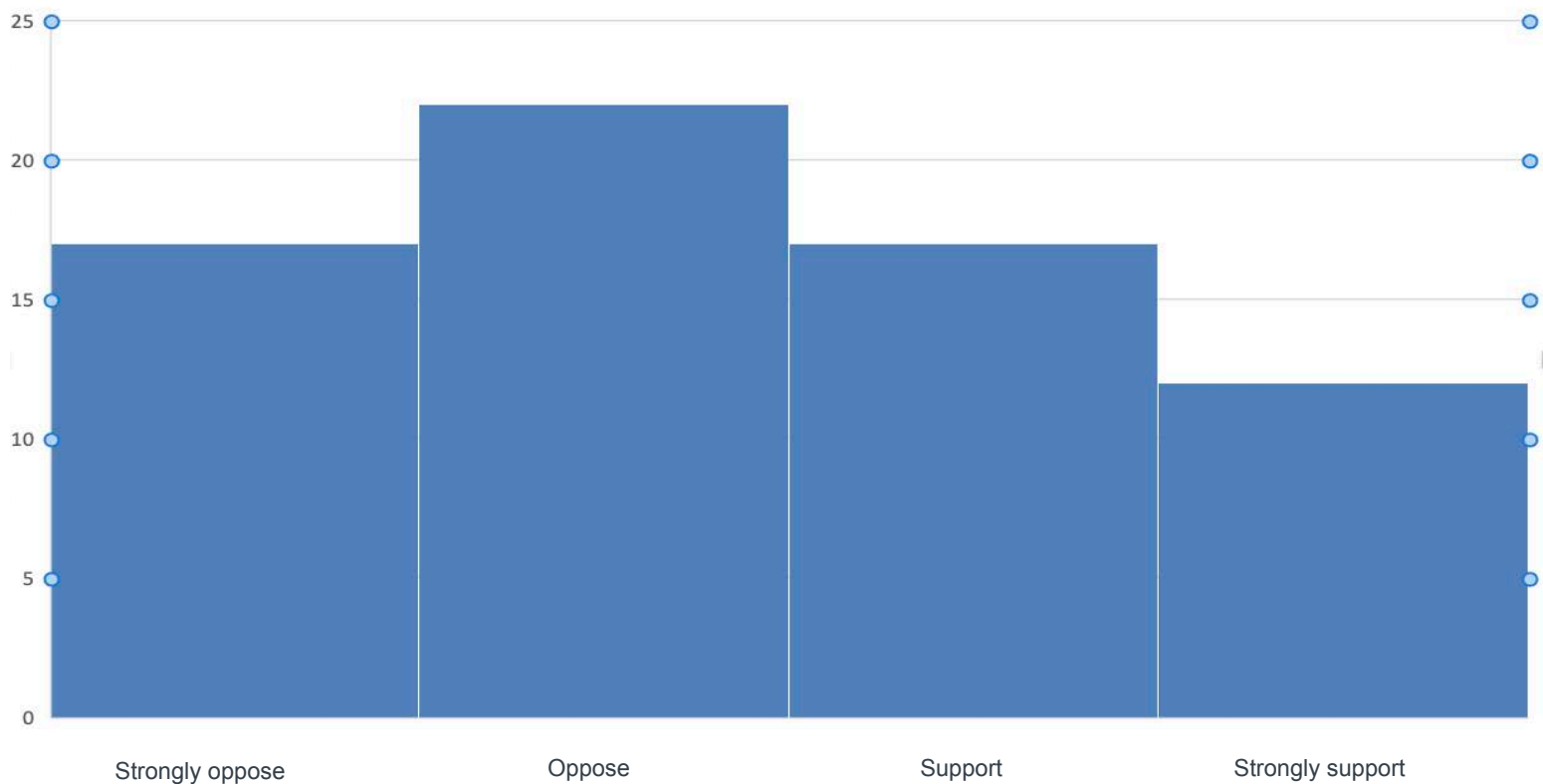

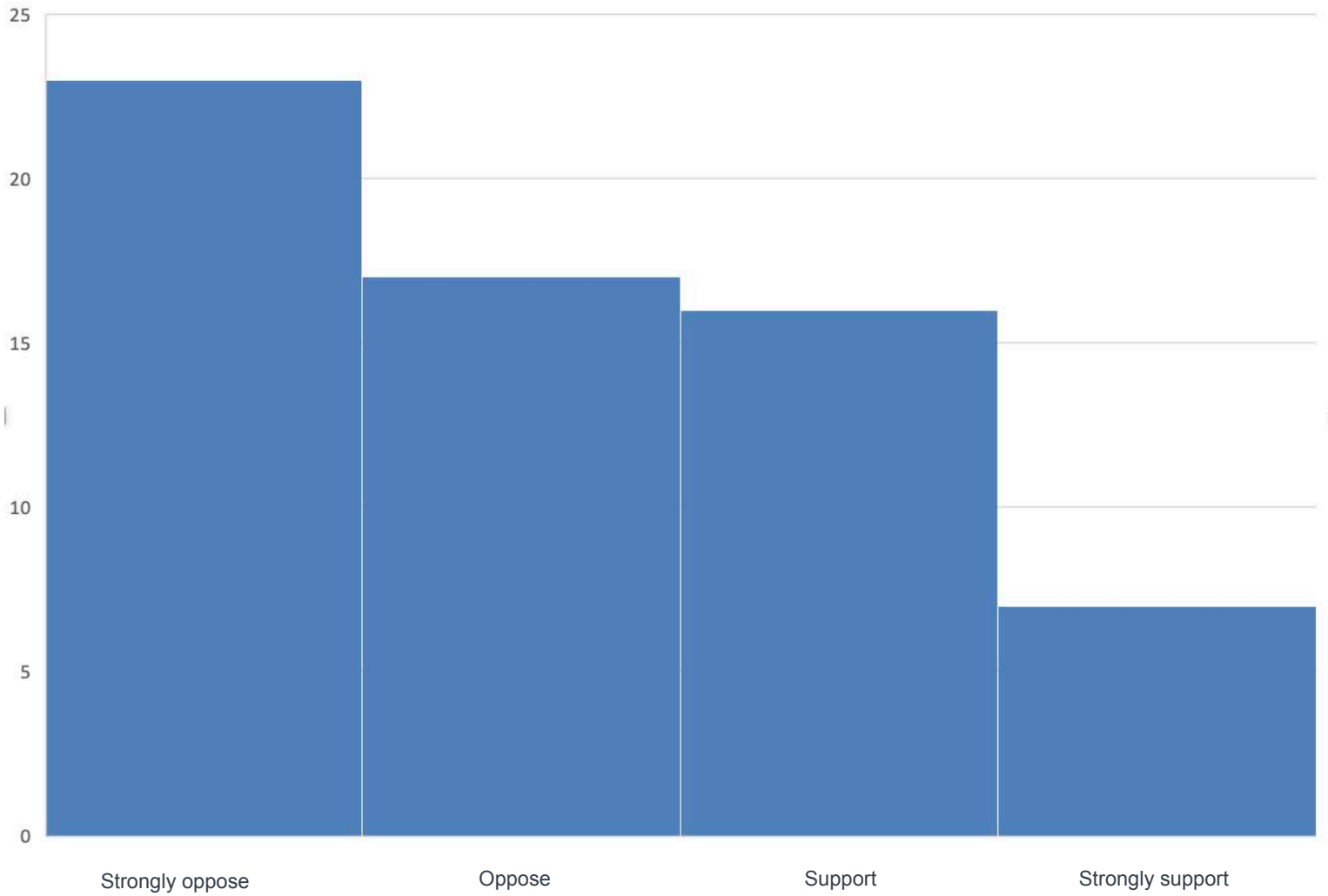
Q17 Do you support the abolition of both CIL and S106 in favour of a single IL

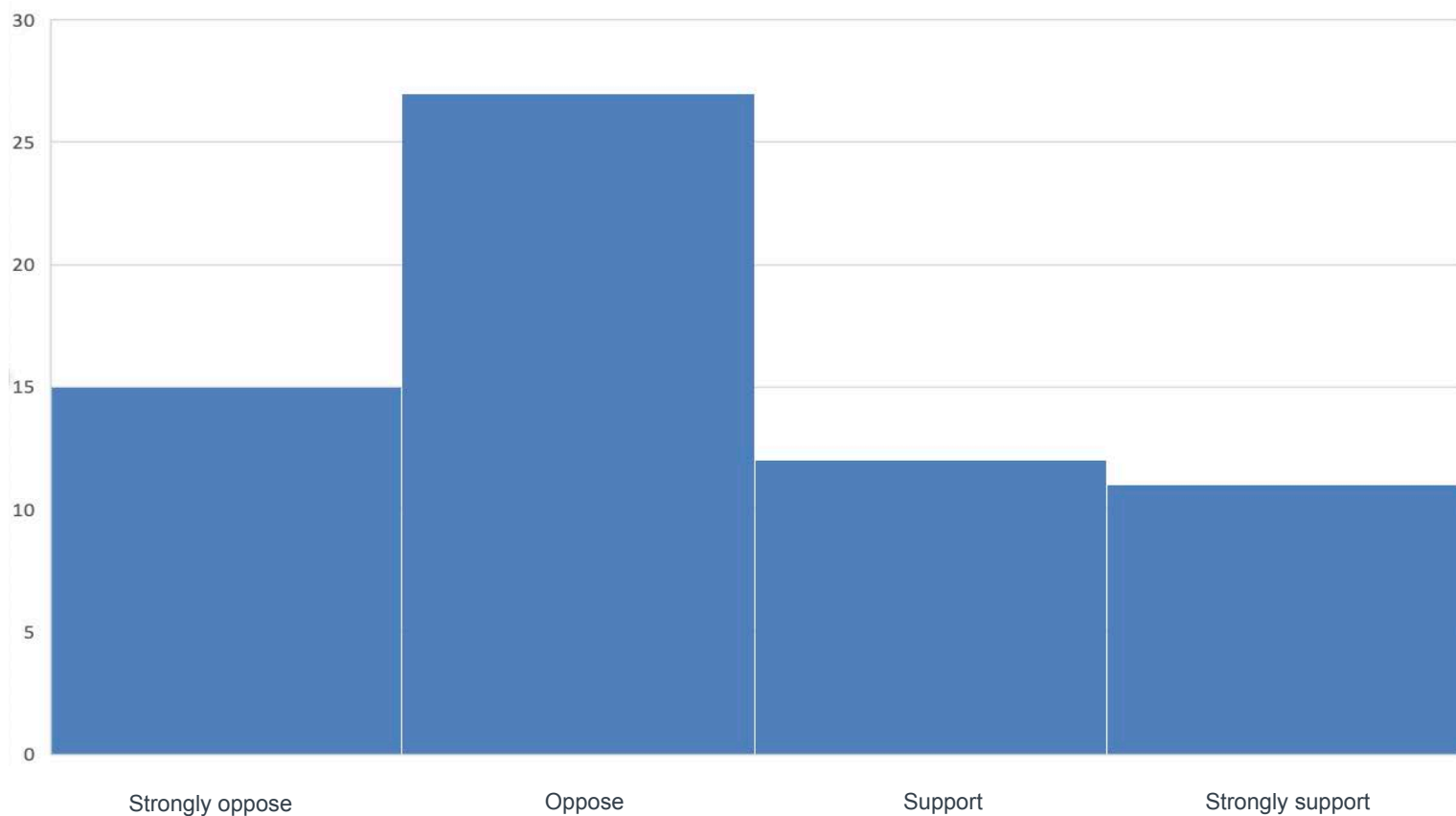


Q19 Do you support a a fast-track planning system for 'beautiful' schemes?



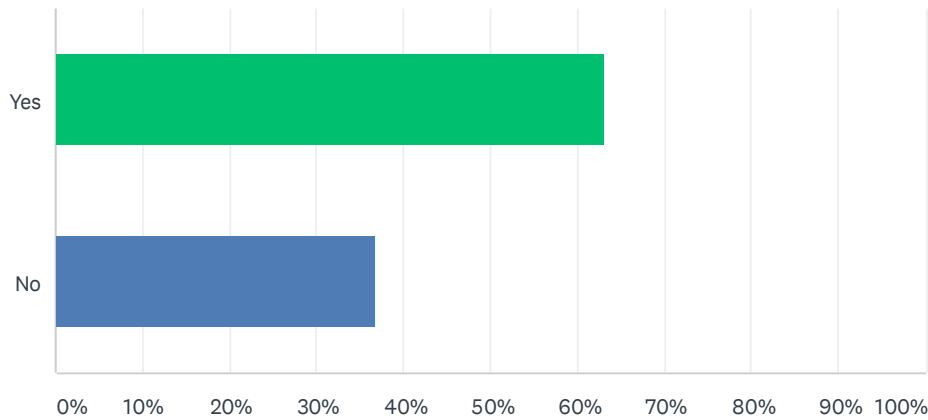
Q21 Do you support the proposals to introduce a national method for setting 'binding' housing requirements within each Local Authority

Q23 Should London be differentiated from the country-wide planning framework with rationale?

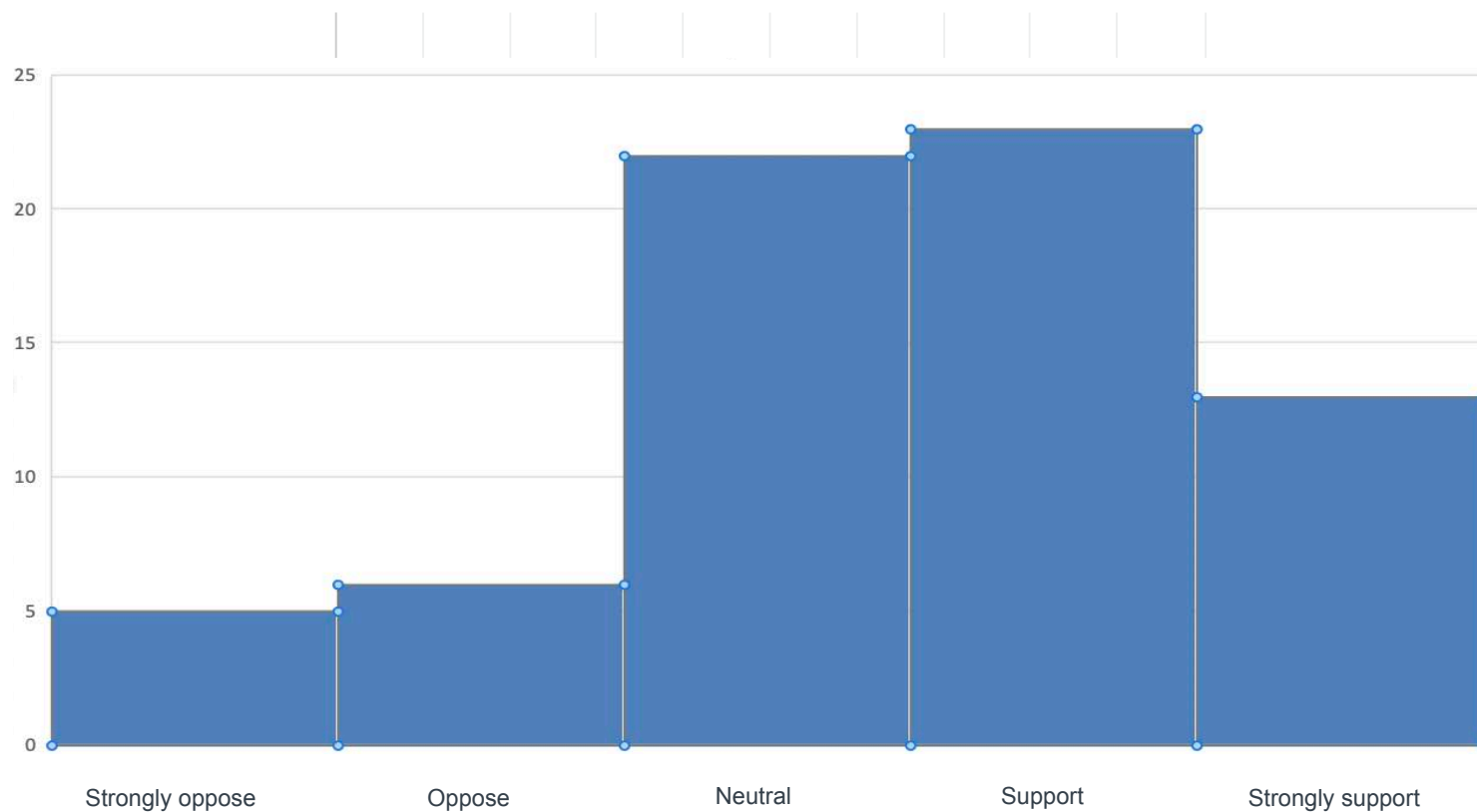

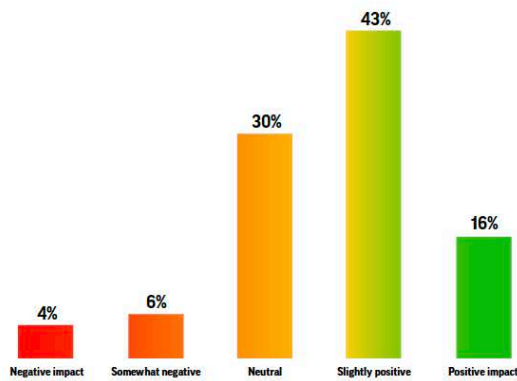
Q24 Do you support the introduction of a quicker, simpler framework assessing environmental impacts?

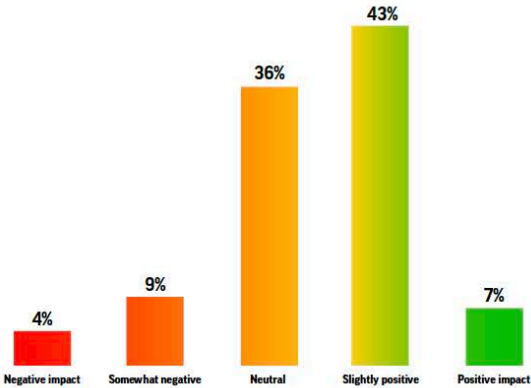
Quantum of development in London



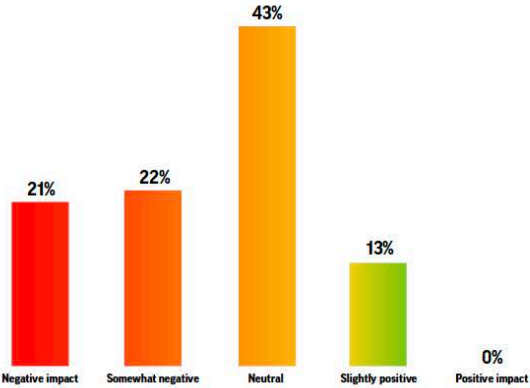
Delivery of affordable housing in London
